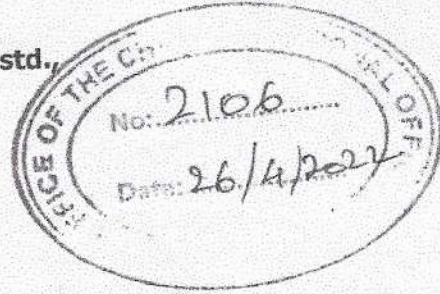


- (a) Two more PST's teaching staff for primary classes and Speical (Music / Drawing) trained teachers should be appointed in the said school.


